WHEREAS, the committee included representatives from Hancock County, the City of Greenfield, Town of Cumberland, Town of McCordsville, Town of Fortville, Town of New Palestine, Town of Spring Lake, and Town of Shirley, and was assisted by Christopher B. Burke Engineering, LLC; and

WHEREAS, the Multi-Hazard Mitigation Plan Update recommends many activities which will protect the people and property of Hancock County including the City of Greenfield, Town of Cumberland, Town of McCordsville, Town of Fortville, Town of New Palestine, Town of Spring Lake, and Town of Shirley which are affected by natural hazards; and

WHEREAS, the City of Greenfield is a participant in the National Flood Insurance Program.
