

ORDINANCE NO. 2018- 14

ORDINANCE AMENDING TITLE VII, CHAPTER 74, SCHEDULES I AND III OF THE CODE OF ORDINANCES OF THE CITY OF GREENFIELD, INDIANA

WHEREAS, the Greenfield Traffic Safety Committee has met and recommended to the Common Council of the City of Greenfield, Indiana, that certain streets be added to the Greenfield Code of Ordinances as preferential streets and that speed limits be established for newly created streets; and

WHEREAS, the Common Council of the City of Greenfield, Indiana, believes that adopting the recommendation of the Traffic Safety Committee is the best interests of the health, safety and welfare of the citizens of Greenfield, Indiana.

THEREFORE BE IT ORDAINED by the Common Council of the City of Greenfield, Indiana that Title VII, Chapter 74, Schedule I and Schedule III should be amended as set forth below:

SECTION I

Title VII, Chapter 74, Schedule I, is hereby amended by the addition of the following preferential streets:

<u>Street or Road</u>	<u>Direction</u>	<u>Stops For</u>
Thistle Wood Drive	Northbound	Longleaf Lane
Pine Wood Drive	Westbound	Rocky Road
Progress Parkway	Southbound	Opportunity Parkway Roundabout

SECTION II

Title VII, Chapter 74, Schedule III, is hereby amended to establish speed limits on newly created streets as follows:

<u>Street</u>	<u>Direction</u>	<u>Speed (M.P.H.)</u>
Progress Parkway	Northbound and southbound	30
Opportunity Parkway	Eastbound and westbound	30

SECTION III

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
