

ORDINANCE 2018 – 13

**AN ORDINANCE AUTHORIZING ADDITIONAL APPROPRIATIONS  
FOR THE FIRE DEPARTMENT**

WHEREAS, the City of Greenfield, in Section 30.20 of the Code of Ordinance, created a Local Option Income Tax Fund (“LOIT FUND”); and

WHEREAS, the utilization of the LOIT FUND shall be for public safety purposes; and

WHEREAS, additional funds are needed to pay for a needs assessment and evaluation of the City of Greenfield Fire Department.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL  
OF THE CITY OF GREENFIELD, INDIANA:**

**SECTION I**

That for the expenses of said City of Greenfield, Indiana, the following additional sums of money are hereby appropriated from the LOIT Public Safety Fund Account #225:

Fire Department Budget

Account #225 Public Safety LOIT not to exceed the amount of \$50,000.00.

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
