To WWTPC Operating Fund 606  
**In the amount of \$392,585.00**

Transfers from one line item to another, or additional appropriations may be made only by Resolution of this Council at a Public Meeting.

The Clerk-Treasurer shall post the approved Voucher to the appropriate budget category as outlined above.
