

ORDINANCE NO. 2018-15

**AN ORDINANCE AMENDING TITLE VII, CHAPTER 74,
SCHEDULES I, II AND VI OF THE CODE OF ORDINANCES
OF THE CITY OF GREENFIELD, INDIANA**

WHEREAS, it has been recommended to the Common Council of the City of Greenfield, Indiana, by the Greenfield Traffic Safety Committee, that certain amendments be made to the Greenfield Code of Ordinances: and

WHEREAS, the Common Council of the City of Greenfield, Indiana, believes that the amendments recommended by the Greenfield Traffic Safety Committee are in the best interest of the health, welfare, and safety of the citizens of Greenfield, Indiana.

THEREFORE, BE IT ORDAINED by the Common Council of the City of Greenfield, Indiana that:

SECTION I

Title VII, Chapter 74, Schedule I, of the Code of Ordinances of the City of Greenfield, Indiana, should be amended by the addition of the following:

East Street	northbound	Grant Street	2018-15

SECTION II

Title VII, Chapter 74, Schedule II, of the Code of Ordinances of the City of Greenfield, Indiana, should be amended by deleting the reference to East Street therefrom.

SECTION III

Title VII, Chapter 74, Schedule VI, of the Code of Ordinances of the City of Greenfield, Indiana, should be amended as follows:

SECTION IV

This Ordinance shall be in full force and effect from and after its passage, approval by the Mayor, and publication as prescribed by law.
