

# ORDINANCE 2018 – 23

## APPROPRIATION ORDINANCE

**WHEREAS**, the Common Council of the City of Greenfield, Indiana, has heretofore adopted an ordinance approving its budget for 2018; and

**WHEREAS**, after due publication, a public hearing was held on December 12th, 2018 at 7:00 p.m. regarding said additional appropriation; and

**WHEREAS**, it has been determined that it is now necessary to appropriate more money than was originally appropriated to the annual budget; and

**WHEREAS**, the Common Council of the City of Greenfield, Indiana, believes an additional appropriation of money from the G.O. Fire Bond Fund to be in the best interest of the health, safety, and welfare of the citizens of Greenfield, Indiana, and the efficient operation of the government of the city of Greenfield, Indiana.

**NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF GREENFIELD, INDIANA:**

### SECTION I

That for the expenses of said City of Greenfield, Indiana, the following additional sums of money are hereby appropriated out of the fund named and for the purpose specified, subject to laws governing the same:

This Ordinance shall be in full force and effect from and after its passage, execution by the Mayor, approval by the Department of Local Government Finance of the state of Indiana, and publication as prescribed by law.
